### ZONING BYLAW AMENDMENT - H01-22 - 173 Huron Street

The City of Stratford is considering an amendment to the City's Zoning By-law 201-2000 and By-law 10-2022 for the lands described below.

The application affects the property with the municipal address of 173 Huron Street, located on Huron Street between John Street and St. Vincent Street North, legally described as Lot 24, Plan 20. The subject lands have an approximate area of 522.9m2 and a frontage of 12.8m.

The proposed Zone Change amendment is to remove the holding provision for the lands zoned Mixed Use Residential (MUR-2-H and MUR-3-H21). The holding provision was put in place to ensure that all work under Building Permit 2017-104771 was completed and inspected to the satisfaction of the Chief Building Official and that the building permit file is closed.
