MINOR VARIANCE APPLICATIONS

A37-21- 115 O'Loane Avenue - Planner: Victoria Nikoltcheva



Purpose: The purpose of this application under Section 44 of the Planning Act, R.S.O. 1990 is to reduce the side yard setback to allow for the construction of a deck extension.

Variances requested:

1. To reduce the side yard setback from 5m to 2.99m for the proposed deck.

A38-21 – 215 Church Street – Planner: Victoria Nikoltcheva



Purpose: The purpose of this application under Section 44 of the Planning Act, R.S.O. 1990 is to reduce the side yard setback for a proposed converted dwelling and to reduce the front yard depth to accommodate a parking space.

Variances requested:

- 2. To reduce the side yard setback from 1m to 0.61m for the converted dwelling.
- 3. To reduce the front yard depth from 7.5m to 0m for a parking space.

A39-21 – 121 Norfolk Street – Planner: Victoria Nikoltcheva



Purpose: The purpose of this application under Section 44 of the Planning Act, R.S.O. 1990 is to reduce the front yard depth to allow for the construction of an addition.

Variances requested:

1. To reduce the front yard depth from 7.5m to 3.15m for a proposed addition.

CONSENT APPLICATIONS

B07-21 – 197 William Street – Planner: Victoria Nikoltcheva



Purpose: The purpose of this application is to sever the property at 197 William Street into two parcels. The severed and retained parcels will both have a frontage of 6m and an area of 181.1m2. The westerly parcel will be added to 195 William Street and the easterly parcel will be added to 199 William Street as lot additions.

B08-21 – 61 Church Street – Planner: Victoria Nikoltcheva



Purpose: The purpose of this application is to create a 1.22m wide, 12.2m long right-of-way over 61 Church Street to grant access to 114 Erie Street for emergency pedestrian egress purposes.

B09-21 – 74 & 76 Church Street – Planner: Jeff Bannon



The purpose of the application is to create a right of way with an approximate width of 3.58m, an approximate depth of 26.59m and an approximate area of 95.2m2. (Parcel C)

B10-21 – 235 St.Patrick Street – Planner: Jeff Bannon



The purpose of the application is to create a right of way with an approximate width of 2.42m, an approximate depth of 26.59m and an approximate area of 64.3m2. (Parcel B)

If you wish to be notified of the decision of the City of Stratford Committee of Adjustment in respect of the proposed consent, you must make a written request to the Secretary-Treasurer, Stratford Committee of Adjustment, Jeff Bannon, 82 Erie Street, 2nd Floor Stratford, ON N5A 2M4. This will also entitle you to be advised of a possible Ontario Land Tribunal hearing. Even if you are the successful party, you should request a copy of the decision since the Stratford Committee of Adjustment decision may be appealed to the Ontario Land Tribunal by the applicant or another member of the public.
